

WP 2012 takes into account the European Research Area (ERA) objectives and recent major EU policy initiatives such as the Flagship Initiatives on Innovation Union and Resource Efficiency.

## Most topic areas are evaluated through a two-stage process:

- Outline proposals of max 10 pages by 20 October 2011;
- Selected outlines to prepare full proposals by 15/2/2012 (indicative date to be specified in the invitation letter);
- In most cases, more than one proposals can be selected; the call text is less prescriptive, leaving more choice to the applicants on what to focus the proposal.

- 15 February 2012 at 17:00

 Specific Programme(s): COOPERATION , Environment





- Understand and operationalise the potential of the ecosystem services and natural capital approach within key regulatory frameworks and in decision making processes.
- Integrated natural, social and economic research is needed to assess the ecosystem services relevant to human well-being, and analyse links between and comparisons across sectors, scales and time (for example, across a coherent set of case studies)
- social-ecological systems must at least include fresh water bodies, coastal zones, urban and rural areas and their interfaces.





- Focusing on the bio-physical control of ecosystem services
- Research will examine the effects of multiple drivers (including the use of renewable resources), structural and functional factors
- human feedbacks on ecosystem services.






- To support the formulation and implementation of regulatory frameworks such as the Water Framework Directive, Air Quality Framework Directive, the Common Agricultural Policy, the Green Infrastructure approach, the Thematic Strategy on the Urban Environment and Environmental Impact Assessments.
- International collaboration, especially in developing countries is strongly encouraged
- Funding Scheme: Collaborative Project
- The requested European Union contribution per project shall not exceed EUR 9 000000
- One or more proposals can be selected.

## **DG REGIO-CITIES OF TOMMOROW**

- Challenges, visions, ways forward
- More than two thirds of the European population lives in urban areas. Cities are places where both problems emerge and solutions are found.
- Cities are fertile ground for science and technology, for culture and innovation, for individual and collective creativity, and for mitigating the impact of climate change.





#### **DG REGIO-CITIES OF TOMMOROW**

- However, cities are also places where problems such as unemployment, segregation and poverty are concentrated.
- We need to better understand the challenges that different European cities will face in the years ahead.
- The aim of this report is to bring together urban experts and representatives of European cities to think about the future.





## DG REGIO –REPORT ON CITIES OF TOMMOROW

- The report raises awareness of the possible future impacts of a range of trends, such as demographic decline and social polarisation, and the vulnerability of different types of cities.
- It also highlights opportunities and the key role cities can play in achieving EU objectives – especially in the implementation of the Europe 2020 strategy.
- It confirms the importance of an integrated approach to urban development.



- Based on relevant scenarios and patterns, to create input for radical innovation, technology development and implementation strategies






#### JPI objectives

Multiannual Financial Framework 2014-2020:

#### **Main issues**

• Stronger focus on the grand global challenges such as climate change and food and energy security, which can only be tackled effectively through cross-border coordinated research.





Multiannual Financial Framework 2014-2020:

- More emphasis on growth creation and on evaluating the economic effect of research and innovation funding.
- Major simplification of procedures to get researchers out of the office and into the labs and to boost SME participation in FP7.





Multiannual Financial Framework 2014-2020:

 On 29th June, the Commission has presented a proposal

• Final amount and breakdown of the EU budget to be decided jointly by the European Parliament and the Council (Member States).







# What is the Green Paper?

- Consulting on major improvements to future EU research and innovation funding
  - Covering the FP, CIP and EIT in a Common Strategic Framework (CSF)
  - With a coherent set of funding instruments along the whole innovation chain (from basic research to market uptake)
- For the next EU Budget (to start in 2014)





### Scope of the Common Strategic Framework, CSF

#### Covering current funding for:

- The 7<sup>th</sup> Framework Programme (FP7) for research, technological development and demonstration
   €53 billion (2007-13). 4 main programmes on Ideas, Cooperation, People and Capacities.
- The Competitiveness and Innovation Framework Programme (CIP)
   ►€3.6 billion (2007-13). 3 programmes on enterprise & innovation, intelligent energy, and ICT policy support.






## The context: Europe 2020 strategy

# Benefits from current EU research and innovation funding (evaluations, other sources)

- Achieve critical mass and diffusion of knowledge
- Promote competition in research and innovation, raising levels of excellence
- Offer training possibilities and enhances Europe's research and innovation capacities
- Provides a way to deal with pan-European policy challenges and link to EU market frameworks
- Raises the international attractiveness of EU research and innovation





#### **But also concerns**

- Further simplification
- Better strategy for innovation involve users, how to commercialise results, generate impacts
- Broaden participation industry, SMEs, new
  Member States, women, new innovation actors
- Clearer agendas driven by scientific, industrial, social objectives
